The National Law Institute University, Bhopal (NLIU) invites applications in the prescribed application form for admission to-

- (i) Ph. D. in Law;
- (ii) Ph.D. (Inter-disciplinary); and
- (iii) Ph.D. in Cyber Law and Information Security

Teaching Assistantship may be provided to non-JRF candidates after completion of their Course-work for two years.

#### **Eligibility for Admission:**

- (a) **Ph. D. in Law:** LL.M. Degree with 55% Marks or equivalent grade in the aggregate for General candidates and 50% marks in the aggregate for SC/ST/OBC (non creamy layer)/ PWD candidates.
- (b) **Ph.D. in Cyber Law and Information Security:** LL.M./MCLIS/M.S. or M.Sc.(IT or Cyber Security/Cyber Forensic)/M.Tech (CSE/IT/Cyber Security/Cyber Forensic) or equivalent Degree for Ph.D. in Cyber Law and Information Security with 55% Marks or equivalent grade in the aggregate for General candidates and 50% marks in the aggregate for SC/ST/OBC (non-creamy layer)/ PWD candidates; as the case may be
- (c) Ph.D. (Inter-disciplinary): (i) Post Graduate degree in any discipline with 55% Marks in the aggregate for General candidates and 50% marks in the aggregate for SC/ST/OBC (non creamy layer)/ PWD candidates and LL.B. degree or its equivalent viz. B.L./B.A.LL.B/B.Com. LL.B/B.Sc. LL.B.;



- (ii) Ten years experience in Academic/Industry/Administration
- (iii) The proposed research is focused on Law & Public Policy

## Procedure for Admission: All India Written Test followed by Interview

For candidate of Ph.D. in Law (Both Full Time & Part Time) and Ph.D. in Inter-disciplinary Research in Law All India Written Test shall be based on the following papers for a total of 100 marks:

(a) Constitutional Law, Jurisprudence, Research Methodology, International Law, Human Rights Law, Family Law, Business Law, Intellectual Property Law, Environmental Law, Criminal Law & Cyber Law.

For Candidates of Ph.D. in Cyber Law and Information Security the All India Written Test shall be based on the following papers for a total of 100 marks:

- (a) Research Methodology,
- (b) Cyber Law
- (c) Information Security
- (d) Fundamentals of Information Technology

Application Form Fee: Rs.1,500/- (One Thousand Five Hundred Only) by way of a Demand Draft drawn in favour of the Director, the National Law Institute University, payable at Bhopal, must be enclosed with the Application Form. ### **Instructions**

- 1. These instructions are in furtherance to the notification given for Admission to Ph. D. Program 2020-21published in the newspaper and uploaded on <a href="https://www.nliu.ac.in">www.nliu.ac.in</a>.
- 2. The Admission to Ph. D. Programs shall be governed by the University Grants Commission (Minimum Standards and Procedure for award of M. Phil / Ph. D. Degree), Regulations 2016 as amended from time to time and the National Law Institute University Rules for Ph. D. Programs.
- 3. To be eligible for admission to Ph.D. Program, the candidate must secure at least 50% marks in the Entrance Test and the Personal Interview conducted by NLIU Bhopal. However, the candidates who have qualified UGC NET/JRF/SLET need not to appear in All India Written Test, but will have to appear for interview before the Interview Board on the notified date.
- 4. Date of ENRANCE TEST and PERSONAL INTERVIEW is MAY 03, 2020.
- 5. The candidates are to apply for admission to the Ph. D. Program 2020-21 alongwith the NO OBJECTION CERTIFICATE (NOC) obtained from their respective Department/Institution.
- **6.** Every candidate admitted to the Ph.D. Program shall be required to stay in Bhopal for the duration of the course work as notified by the university.
- 7. There are three types of Ph. D. Programs offered by the NLIU:
  - i. Ph. D. in Law,
  - ii. Ph.D. (Inter-disciplinary) &
  - iii. Ph.D. in Cyber Law and Information Security

These three Programs are also offered in Part Time subject to eligibility Conditions.



- 8. English shall be the language of written test, interview, course work, doctoral thesis and examination.
- 9. The candidate shall enclose, with the application form, the attested copies of all the mark sheets, certificates of examinations, degrees, caste certificates, certificate of person with disability, Experience Certificate and other relevant certificates.
- 10. Fees including the application fee (except the refundable fees) once deposited shall not be refunded. The candidates must note this point before depositing the fees. The University reserves the right to revise the fee and charges from time to time.
- 11. There are two copies of Admit Card. First is the 'candidate's copy' and the other is the 'office copy'. The candidate <a href="shall not">shall not</a> put his/her signature on the 'candidate's copy' for it is to be signed by him/her in the examination hall. However, the candidate <a href="shall">shall</a> put his/her signature on the 'office copy' of the Admit Card.
- 12. The candidates shall submit application form without any corrections/cutting or overwriting.
- 13. The candidate shall ensure that the application form must be received by the office of the Registrar, NLIU on or before April 25, 2020 through **Registered/Speed Post** only. The University shall not be liable for any delay on the part of the candidate or post office in submitting the application form.
- 14. The candidate shall visit the www.nliu.ac.in regularly for the date(s) of declaration of result and date of admission.
- 15. The candidates shall ensure that the following documents are enclosed with the duly filled in application form:
  - (i) Application Fee of Rs. 1,500 (One Thousand Five Hundred Only) by way of a Demand Draft drawn in favour of the "Director, the National Law Institute University, Bhopal". The candidate must clearly write his/her full name, date of birth and telephone number on the back of the Demand Draft.

- (iii) **Synopsis of Proposed Work:** Application alongwith the research proposal of about ten (10) pages to be submitted containing the following:
  - (a) Title
  - (b) The background literature on the subject,
  - (c) The Statement of Problem,
  - (d) Research Questions, Hypothesis & Methodology
  - (e) Research Design
  - (f) In addition to the above, the research proposal for inter-disciplinary research shall have components bearing on law & Public Policy.
